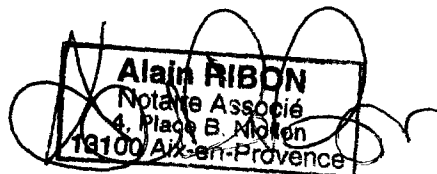
ATTESTATION

- *November 29, 1935 : Constitution of a Limited Liability Company named «PARFUMERIE FRAGONARD GEORGES FUCHS & CIE».*
- *December 31, 1963 : Conversion of the Limited Liability Company into a Limited Company with the same name.*
- *December 17, 1987 : Abandon of the name «PARFUMERIE FRAGONARD GEORGES FUCHS & CIE». The Company will be called from now on «PARFUMERIE FRAGONARD».*
- *November 23, 1995 : After the merger, the new name for all the companies having activities of perfumes and candies is «SOCIETE NOUVELLE DE PARFUMERIE ET DE CONFISERIE».*
- *December 28, 1995 : After the split, «LES PARFUMERIES FRAGONARD» becomes the new name.*
