Reference is made to that certain Credit Agreement, dated as of April 15, 1996 among Brunswick Biomedical Corporation, as Borrower, various lenders and Internationale Nederlanden (U.S.) Capital Corporation, now known as ING (U.S.) Capital LLC ("ING"), as agent for the lenders, as such Credit Agreement has been amended (as so amended, the "Credit Agreement"). The obligations of Brunswick Biomedical Corporation with respect to the Credit Agreement have been assumed in their entirety by Meridian Medical Technologies, Inc. ("Meridian") as contemplated by the Credit Agreement. Unless otherwise defined herein, capitalized terms used herein shall have the respective meanings ascribed to them in the Credit Agreement.

ING hereby confirms that as of the date hereof, the outstanding principal balance, interest, commitment fee and other sums due to ING from Meridian under the Credit Agreement are as follows:

provided, however, that all provisions of the Credit Agreement and the other Loan Documents which pursuant to the terms of the Loan Documents are to survive the termination of the Credit Agreement or repayment of the Loans (including, without limitation, those provisions described in Section 9.5 of the Credit Agreement) shall so survive, shall not be deemed terminated and shall be and remain in full force and effect. Upon receipt by ING of immediately available funds equal to the Payoff Amount, (i) ING will also execute and deliver to Meridian, if requested, such UCC termination statements for all financing statements filed by ING in UCC jurisdictions and lien release and discharge documents in each case covering or relating to any assets, real or personal property or other collateral pledged to ING in connection with the Credit Agreement, and (ii) ING hereby authorizes Meridian and/or Meridian's lender, Fleet National Bank ("Fleet") along with their respective counsel to file such UCC termination statements, lien release and discharge documents without the signature of ING in the event such signature is not required by the relevant document.
