

(ii) Any and all rights and causes of action to recover past, present, or future damages, royalties, fees, profits, or other relief, including equitable or injunctive relief, arising from infringement of the Marks to which Assignor would have been entitled had the Assignment not been made.

The Marks and the associated goodwill is to be held and enjoyed by Assignee, for the exclusive use and benefit of Assignee and Assignee's representatives, successors, and assigns, as fully and entirely as the same would be held and enjoyed by Assignor had this Assignment not been made.
