 - A. in the preparation and prosecution of any applications for registration or any applications for renewal of registrations covering any of the Trademarks;
 - B. in the prosecution or defense of any opposition, interference, infringement suits or other proceedings arising from or relating to the Trademarks, including testifying as to any facts relating to the Trademarks or this Assignment (however, in the even of any opposition, interference, infringement suit or other proceeding that may arise in connection with the Trademarks or this Assignment, Assignee agrees to bear the entire cost thereof and will be entitled to retain the entire amount of any recovery or settlement. Assignor may, if it so desires, also be represented by counsel of its own selection, the fees for which counsel will be paid by Assignor); and
