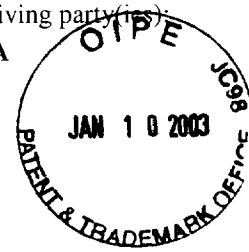

WHEREAS the Assignee agrees to purchase, and the Assignor agrees to sell to the Assignee all right, title and interest in and to the Intellectual Property Rights.

NOW THEREFORE, for good and valuable consideration, the receipt of which is duly acknowledged, it is hereby agreed as follows:



2. The Assignor represents and warrants to the Assignee that it has, where applicable, good and valid title to all Intellectual Property Rights being conveyed.
3. The Assignor warrants in favour of the Assignee that at the date hereof, the Trademark Applications are subsisting and that nothing has been done nor has any event occurred whereby the same may be declared void or invalidated. The Assignor does not however warrant the applications will be registered or protected.



6. The Assignor further undertakes to execute, and/or have executed, any and all documentation necessary to confirm and/or to maintain in full force and effect any license recordals, authorised use recordals, wherever necessary or appropriate to effectuate in full the Assignment herein.
7. The Assignor appoints and constitutes the Assignee as its attorney-in-fact, with full power of substitution, for and on behalf of such Assignor in relation to any purpose or action necessary or appropriate to effectuate and/or confirm the Assignment herein. For the purposes of recordal of the effects of the Assignment with the competent intellectual property administrations of the countries concerned, the Assignee authorizes Marc Frisanco and Bernard Ibos having their address for business purposes at Berkeley Intellectual Property Services, 8, Boulevard James-Fazy, 1211 Geneva 2, to represent said Assignee and to act for and on its behalf both jointly and separately.
