

**GRANT OF SECURITY INTEREST IN U.S. TRADEMARK**

**BE IT KNOWN** that Elima IP Holdings, LLC, a Delaware limited liability company with a principal business address of 1100 W. Littleton Blvd. Suite 360, Littleton, Colorado 80120 ("Debtor"), is obligated to Newman Family Western, LP, a limited partnership formed under the laws of Nevada, with a principal business address of 4535 W. Sahara Blvd, Suite 204, Las Vegas, Nevada 89102 ("Newman"); Terry L. Jones, an individual residing at 611 Butternut Street, NW, Washington, DC 20012 ("Jones"); and Syndicated Communications, Inc., a corporation formed under the laws of Delaware, with a principal business address of 8401 Colesville Rd., Silver Spring, Maryland 20910 ("Syndicated") (Newman, Jones and Syndicated are collectively the "Secured Parties"), and has entered into a Loan and Security Agreement of even date (the "Loan Agreement") in favor of the Secured Parties. For good and valuable consideration, the receipt of which is hereby acknowledged, and for the purpose of recording the grant of the security interest as aforesaid, the Debtor does hereby further assign to the Secured Parties, and grant to the Secured Parties, subject to the provisions of the Loan Agreement, a security interest in, the Trademark to secure the prompt payment, performance and observance of the Obligations.

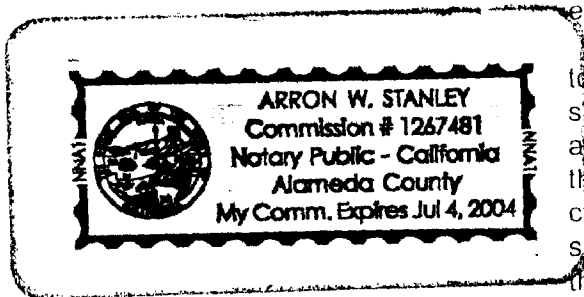

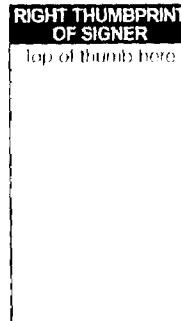
