**THIRD:** The surviving constituent entity in the merger herein certified is IntellEquip, LLC (the "Surviving LLC").

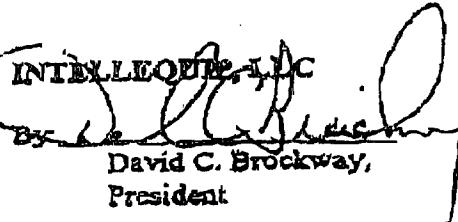
**FOURTH:** At the Effective Time (as specified in Article Seventh below), the Certificate of Formation of the Surviving LLC shall be its Certificate of Formation.

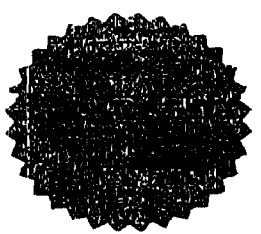
