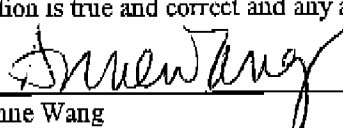

2. The following amendment of the Articles of Incorporation of said corporation has been approved by the Board of Directors of the corporation.

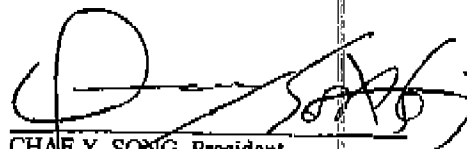
Article One of the Articles of Corporation of this corporation is amended to read as follows:

One: The name of this corporation is CROSSFIRE, INC.

3. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporation code. The total number of outstanding shares of the corporation is 150,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
