

ASSIGNMENT OF TRADEMARKS

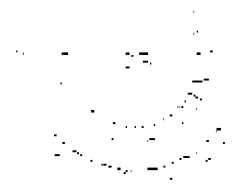


