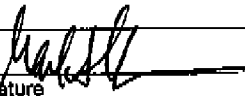

**CERTIFICATE OF AMENDMENT  
TO THE  
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF  
RASTER GRAPHICS, INC.**

Raster Graphics, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify as follows:

**FIRST:** That by unanimous written consent pursuant to Section 141(f) of the General Corporation Law of the State of Delaware a resolution of the Board of Directors of the Corporation was duly adopted setting forth a proposed amendment to the Amended and Restated Certificate of Incorporation of the Corporation, deeming said amendment to be advisable and directing that the consent of the sole stockholder of the Corporation be obtained by written consent or by calling a meeting of the stockholder for consideration thereof. The resolution setting forth the proposed amendment is as follows:

**RESOLVED,** that the Amended and Restated Certificate of Incorporation of the Corporation be amended by changing the name of the Corporation from Raster Graphics, Inc. to Oct Display Graphics Systems, Inc.

**SECOND:** That pursuant to resolution of its Board of Directors and Section 229 of the General Corporation Law of the State of Delaware, the sole stockholder of the Corporation consented to the amendment in writing.

**THIRD:** That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.

**FOURTH:** That the capital of the Corporation shall not be reduced under or by reason of said amendment.

**IN WITNESS WHEREOF,** the Corporation has caused this Certificate of Amendment to be duly executed on the 27<sup>th</sup> day of May, 2002.
