
WHEREAS, Administrative Agent and **WALSH HEALTHCARE SOLUTIONS, INC.**, an Arkansas corporation, **WALSH HEARTLAND, L.L.C.**, an Arkansas limited liability company, **WALSH SOUTHWEST, L.L.C.**, a Texas limited liability company, **WALSH DISTRIBUTION, L.L.C.**, an Arkansas limited liability company, and **RXDIRECT, INC.**, a Texas corporation ("**Grantors**"), having their chief executive office and principal place of business at 1702 Hampton Road, Texarkana, Texas 75503 are parties to a Guaranty and Security Agreement (the "**Agreement**") dated April 28, 2000, recorded on May 22, 2000 in the United States Patent and Trademark Office commencing at Reel No. 2090, Frame No. 0265, whereby Grantors granted to Administrative Agent a security interest in and to the trademarks, trademark registrations and pending applications for registration (the "**Trademarks**") of Grantors, as identified and/or described in the Agreement; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby reassigns to Grantors all of its right, title and interest in and to the Released Trademarks and to the extent that the Agreement created a security interest in such Released Trademarks, Administrative Agent hereby releases such security interest.
