RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Conferon, Inc., an Ohio corporation ("Conferon"), pledged and granted to The Provident Bank as Agent (in such capacity, the "Agent") for the Lenders party to the Credit Agreement, as amended, by and among Conferon, the Agent and the Lenders, a security interest in the property described in the Credit Agreement (as amended, supplemented or otherwise modified, the "Credit Agreement"), which property includes general intangibles, including, without limitation, (a) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, other business identifiers, prints and labels on which any of the foregoing have appeared or appear, all registrations and recordings thereof, and all applications in connection therewith including, without limitation, those listed in Exhibit A attached hereto and on any schedule to any Trademark Security Agreement; (b) all renewals thereof; (c) all income, royalties, damages and payments now or hereafter due and/or payable under any of the foregoing (including the renewals thereof) or with respect to any of the foregoing (including the renewals thereof) including, without limitation, damages and payments for past, present and future infringements of any of the foregoing; (d) the right to sue for past, present and future infringement of any of the foregoing; (e) all rights corresponding to any of the foregoing throughout the world; and (f) all goodwill associated with and symbolized by any of the foregoing ("Trademarks"); and

WHEREAS, Conferon executed a Trademark Security Agreement dated as of November 23, 1999 (as amended, supplemented or otherwise modified, the "Trademark Security Agreement"), transferring the rights in and to the Trademarks identified in Exhibit A attached hereto, and incorporated herein by reference, to the Agent.

NOW, THEREFORE, for good and valuable consideration, the Agent does, for recording purposes, hereby release and discharge the security interest, liens, and all other rights it may have in the Trademarks identified in Exhibit A attached hereto, granted to it by Conferon pursuant to the Trademark Agreement, and which was recorded on January 19, 2000, at Reel 2019/0185, Frame 0164, in the United States Patent and Trademark Office, to which reference may be had, the debt secured thereby having been paid and satisfied in full.
