WHEREAS, Miller is the owner of the trademark "Celis", the United States trademark registration therefor (U.S. Registration No. 2,338,622, which issued on April 4, 2000 for "beer" in International Class 032), and the goodwill associated therewith, all as such rights relate solely to the United States, its territories and possessions (the "Trademark"); and

WHEREAS, Michigan Brewing wishes to acquire the Trademark.


