

W I T N E S S E T H:

Lender hereby re-assigns and re-transfers to Assignor **WITHOUT RECOURSE** any right, title and interest in and to the Trademarks and any United States trademark application or registration reflecting the Trademarks, together with any right, title and interest in any cause of action that has heretofore arisen or may hereafter arise, with respect to any Trademark..
3. Assignor and Lender hereby acknowledge and agree that the Conditional Assignment is terminated as of the date of this Agreement.
4. The date of this Agreement first set forth above is for identification purposes only and is the date this Agreement is deemed to have been delivered by the Lender to the Assignor. This Agreement was executed by the parties on the date set forth in the acknowledgements below.

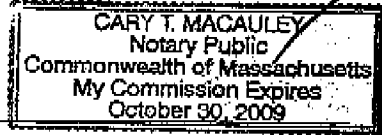
