BANK BILL OF SALE

Bill of Sale ("**Bank Bill of Sale**") dated as of March 27, 2003, made between THE BANK OF NEW YORK, a New York corporation ("**Bank**"), and HOLLAND USA, INC., a Minnesota corporation ("**Buyer**").

Bank, Buyer, and Argosy Investment Partners, L.P., have entered into a Foreclosure Sale Agreement dated as of March 27, 2003 ("**Foreclosure Sale Agreement**"). All capitalized terms not otherwise defined herein shall have the respective meanings provided in the Foreclosure Sale Agreement, and all terms not defined herein or therein shall have the meanings, if any, provided in the Uniform Commercial Code as now in effect in the States of New York ("**NYUCC**") and Connecticut ("**CTUCC**").

NOW THEREFORE, for good and valuable consideration (including the payment by Buyer of the Purchase Price), the receipt of which is hereby acknowledged:

1. **Assignment.** Bank does hereby sell, transfer, assign, convey and deliver to Buyer, and Buyer does purchase all of the right, title, and interest, if any, of UNION PEN COMPANY, a Connecticut corporation ("**Debtor**"), in and to the following described tangible and intangible assets and properties wherever located ("**Bank Conveyed Collateral**"):

Collectively, all of that certain collateral of Debtor that is identified on Exhibit A (including schedules thereto) attached to this Bank Bill of Sale, but specifically excluding all of that certain collateral of Debtor that is identified on Exhibit B (including schedules thereto) attached to this Bank Bill of Sale ("**Bank Excluded Collateral**").

2. **Scope of Assignment.** Bank's conveyance to Buyer of Debtor's right, title, and interest in and to the Bank Conveyed Collateral, if any, shall effect a transfer of possession and ownership of the Bank Conveyed Collateral to Buyer as and to the fullest extent that may be conveyed by Bank as a secured party by means of a foreclosure sale pursuant to §§ 9-610 and 9-617 of the NYUCC and §§ 9-610 and 9-617 of the CTUCC. Furthermore, Bank's conveyance to Buyer of Debtor's right, title, and interest in and to the Bank Conveyed Collateral, if any, shall effect a transfer of possession and ownership of the Bank Conveyed Collateral to Buyer free and clear of all liens, security interests, encumbrances and other rights and interests therein as and to the fullest extent provided in §§ 9-610 and 9-617 of the NYUCC and §§ 9-610 and 9-617 of the CTUCC.

3. **Governing Law.** This Bank Bill of Sale shall be governed by the laws of the State of New York without regard to its conflicts of law principles.

4. **Bank Disclaimers.** By acceptance of delivery of the Bank Conveyed Collateral, Buyer acknowledges that the Bank Conveyed Collateral is conveyed to Buyer "where is" and "as is" without any warranty of fitness for a particular use or other warranty of any kind, except as is otherwise expressly set forth in Section 10 of the Foreclosure Sale Agreement. **WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, BANK SPECIFICALLY DISCLAIMS (A) ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WITH RESPECT TO THE BANK CONVEYED**
