TRADEMARK ASSIGNMENT

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably and unconditionally sells, assigns, transfers and conveys to Assignee its entire right, title and interest in and to the Mark and said Application and all rights of registration and renewal thereof and any other intellectual property rights associated therewith that are currently or may hereafter be recognized, and as to any medium now existing or hereafter discovered or invented, together with the goodwill of the business symbolized by the Mark and the right to sue for past infringement and to collect all damages or profits for past infringements for its own use and benefit.

Assignor agrees to promptly execute all instruments reasonably necessary to evidence the assignment of the Mark and the Application to Assignee.

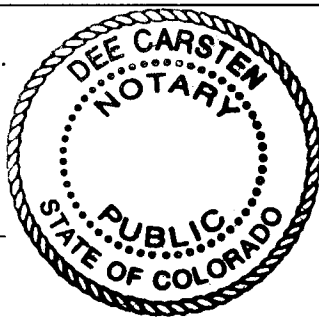
