NUNC PRO TUNC ASSIGNMENT AND BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS, that GOOD LAD CO., INC., a Pennsylvania corporation whose registered mailing address is 431 E. Tioga Street, Philadelphia, PA 19134 (the "Transferor"), for good and valuable consideration paid by WONG SUN HING LTD., a Pennsylvania corporation whose registered mailing address is 3023 W. Coulter Street, Philadelphia, PA 19129 (the "Transferee"), the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, did hereby grant, bargain, sell, convey, set over, transfer, assign and deliver to Transferee, its successors and assigns, in connection with Transferee's foreclosure on Transferor's assets pursuant to, inter alia, that certain Consent and Repossession of Collateral Agreement between, among others, Transferor and Transferee dated June 15, 1999, the following (collectively, the "Personal Property"), nunc pro tunc to July 6, 1999:

Transferee hereby acknowledges and agrees that it accepts the Personal Property in its "AS IS" condition with all faults, if any, and without warranty, express or implied, except as expressly set forth herein.
