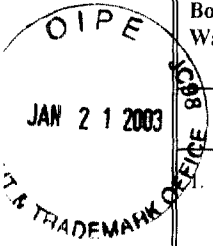

**TRADEMARK ASSIGNMENT**

This Assignment, made and entered into this 30<sup>th</sup> day of September, 1977, by and between Business Records Corporation, a Delaware corporation, located at 7800 Stemmons Freeway, Dallas, Texas 75247, hereinafter referred to as "Assignor," and Smurfit Packaging Corporation, a Delaware corporation, located at 8182 Maryland Avenue, St. Louis, Missouri 63105, hereinafter referred to as "Assignee."

WHEREAS, Assignor has obtained the United States trademark registration No. 1,524,218, upon the term OPTECH, said mark registering on February 14, 1989, for distinguishing the marketing of data tabulating equipment, including specifically electronic data tabulating units and ballots sold as a unit, and herein desires to assign said mark, and its registration, to Assignee;

WHEREAS, Assignee herein desires to obtain an assignment of the aforesaid trademark, and its registration, from Assignor.

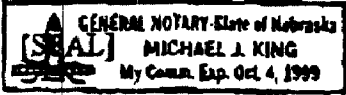
