**GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS AND PATENTS**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Edsal Sandusky Corporation, an Illinois corporation (the "Grantor") with principal offices at 4400 South Packers Avenue, Chicago, Illinois 60609-3314, hereby grants to American National Bank and Trust Company of Chicago, with principal offices at 120 South LaSalle Street, 2nd Floor, Chicago, Illinois 60603 (the "Grantee"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all of the Grantor's rights, title and interest in and to the United States patents and patent applications (the "Patents") set forth on Schedule B attached hereto, in each case together with (iii) all "proceeds" (as such term is defined in the Security Agreement referred below) and products of the Marks and Patents, (iv) the goodwill of the businesses with which the Marks are associated and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Patents or unfair competition regarding the same and all damages awarded therefrom.

THIS GRANT is made to secure the payment of all the Liabilities of the Grantor, as such term is defined in the Continuing Security Agreement between the Grantor and the Grantee, dated as of July 16, 2002 (as amended from time to time, the "Security Agreement"). Upon the occurrence of 1) the Notes (as defined in the Credit Agreement between the Grantor and the Grantee, dated as of July 16, 2002, as amended from time to time, the "Credit Agreement") having been irrevocably paid in full, 2) the Credit Facilities (as defined in the Credit Agreement) having been terminated, and 3) any other Liabilities having been irrevocably paid in full, then the Grantee shall, upon such satisfaction, execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Marks and Patents acquired under this Grant. Grantor shall be obligated to complete all pending applications and to maintain in force all Marks and Patents set forth on the attached schedules until such time as the Notes and the Liabilities have been irrevocably paid in full and the Credit Facilities have been terminated.

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. Except as specifically provided herein, the rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement and the Credit Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement or the Credit Agreement, the provisions of the Credit Agreement shall govern, and if no provisions in the Credit Agreement are applicable, then the provisions of the Security Agreement shall govern.

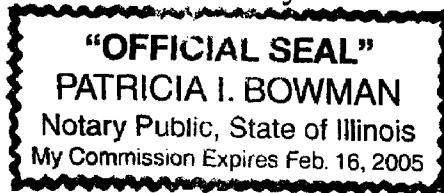

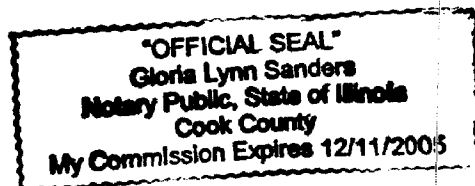


