RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated December 27, 2002 by Harris Trust and Savings Bank, as agent, as hereinafter described;

WITNESSETH:

WHEREAS, Harris Trust and Savings Bank, an Illinois banking corporation, as administrative and collateral agent, with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (Harris Trust and Savings Bank in its capacity as such Administrative and Collateral Agent, is referred to herein as the "Secured Party") and Wholesome Sweeteners, LLC, a Florida limited liability company with its mailing address at 2 East Bryan Street, Savannah, Georgia 31402 (the "Debtor") are parties to a certain Trademark Collateral Agreement dated July 28, 2000 which was recorded in the United States Patent and Trademark Office on August 7, 2000 at Reel 002126, Frame 0545 (the "Assignment"), pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks listed on Schedule A attached hereto and certain other property (collectively the "Trademarks"); and

WHEREAS, the Debtor has requested that the Secured Party release its security interests in the Trademarks and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:



- (ii) The goodwill of the business to which each of the Trademarks relates.
