


2. *Governing Law.* This Assignment of Trademarks shall be governed by, and construed in accordance with, the laws of the State of New York.

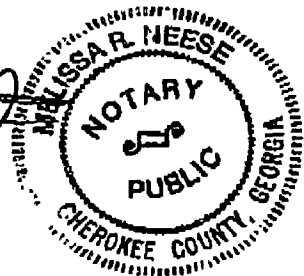


