



ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, CM PUBLISHING LIMITED PARTNERSHIP, a limited partnership formed under the laws of Delaware (the "Trademark Owner"), has adopted, used and is using the trademarks and/or service marks listed on the annexed Schedule A, which trademarks and/or service marks are registered or the subject of pending applications for registration in the United States Patent and Trademark Office (the "Trademarks"); and

WHEREAS, Trademark Owner is obligated to IBJ Whitehall Bank & Trust Company, a New York banking corporation doing business at One State Street Plaza, New York, New York 10004 ("Secured Party"), and has entered into a security agreement dated August 24, 2000, as amended by Master Reaffirmation and Amendment of Collateral Documents in favor of Secured Party dated November 13, 2001; and

WHEREAS, Secured Party was appointed as administrative agent for itself and other lenders pursuant to that certain Credit Agreement dated as of August 24, 2000, as amended by Waiver and Amendment No. 1 to Credit Agreement dated November 13, 2001 (the "Credit Agreement"); and

WHEREAS, pursuant to an Agreement of Resignation, Appointment and Acceptance dated July 22, 2002, Secured Party has resigned as Administrative Agent under the Credit Agreement and The Bank of New York, a New York banking corporation ("Assignee") has been appointed as successor Administrative Agent under the Credit Agreement; and


WHEREAS, Secured Party wishes to assign all of its interest in the Trademarks to Assignee;

NOW THEREFORE, for good and valuable consideration, and subject to the terms of the Credit Agreement and the Security Agreement, Secured Party hereby assigns to Assignee all of Secured Party's security interest in, and mortgage on, all right, title and interest of the Trademark Owner in and to the Trademarks, together with Secured Party's interest in the goodwill of the Trademark Owner's business connected with the use of and symbolized by the Trademarks, and all proceeds thereof, including without limitation, any and all causes of action for infringement thereof and any and all royalties for any licenses thereof, to secure the prompt payment, performance and observance of the Obligations, as defined in the Security Agreement.
