Assignors jointly and severally represent and warrant that they have made no assignment, grant, mortgage, license, or other agreement affecting the Trademark Rights herein conveyed, that they have the full right to convey those rights, and that, to the best of their knowledge, there are no claims by third parties that any use of the Trademark Rights infringes the rights of others.

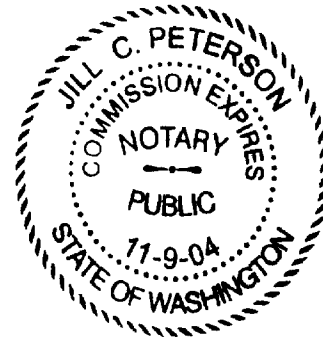
