**TERMINATION AND RELEASE
OF
SECURITY INTEREST IN PATENTS AND TRADEMARKS**

This Termination and Release of Security Interest in Patents and Trademarks (hereinafter, the "Termination and Release") is executed by Comdisco Ventures, Inc. (successor in interest to Comdisco, Inc., "Secured Party"), in favor of Ventaso, Inc., a California corporation ("Debtor").

RECITALS

A. Debtor executed that certain Collateral Grant of Security Interest of Patents and Trademarks, dated as of September 1, 2001 (as amended, restated, modified or supplemented from time to time, the "Grant of Security Interest"), in favor of Secured Party, in connection with that certain Subordinated Loan and Security Agreement, dated as of October 6, 1999, by and between Debtor and Secured Party (as amended, restated, modified or supplemented from time to time, the "Loan Agreement") and that certain Reimbursement and Security Agreement, dated as of June 19, 2000, by and between Debtor and Secured Party (as amended, restated, modified or supplemented from time to time, the "Reimbursement Agreement").

B. Pursuant to the Grant of Security Interest, Debtor granted to Secured Party a security interest in certain intellectual property.

C. The Grant of Security Interest was filed with a Recordation Form Cover Sheet with the Patent and Trademark Office (i) in the case of Patents on December 11, 2001, with Reel/Frame Number: 012374/0705; and (ii) in the case of Trademarks on December 11, 2001, with Reel/Frame Number: 002408/0621.

D. Debtor has paid all amounts owing under the Loan Agreement and the Reimbursement Agreement, and has met all other obligations thereunder.

The Secured Party therefore expressly terminates and releases its security interest in the Intellectual Property Collateral, including without limitation, the patents and patent applications listed on Schedule A hereto and the trademarks and trademark applications listed on Schedule B hereto.

Comdisco Ventures, Inc. hereby represents and warrants that it is the successor in interest to Comdisco, Inc. with respect to the Grant of Security Interest, the Loan Agreement and the Reimbursement Agreement.

Unless otherwise defined herein, all other capitalized terms used herein and defined in this Termination and Release shall have the respective meanings given to those terms in the Grant of Security Interest.
