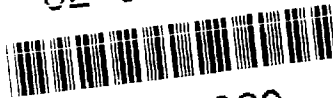

**ASSIGNMENT OF PROPRIETARY RIGHTS
IN INTELLECTUAL PROPERTY**

ASSIGNMENT OF PROPRIETARY RIGHTS IN INTELLECTUAL PROPERTY (this "**Assignment**"), dated as of January 6, 2003, by The North Face, Inc., a Delaware corporation having its principal place of business at San Leandro, California (the "**Assignor**"):

WITNESSETH:

WHEREAS, the Assignor is the owner of the Intellectual Property, as defined hereinbelow;

WHEREAS, The North Face Apparel Corp., a Delaware corporation (the "**Assignee**"), having its principal place of business at Wilmington, Delaware, is desirous of acquiring the Assignor's entire right, title and interest in and to and under the Intellectual Property, as defined hereinbelow;

WHEREAS, the Assignor has agreed to transfer to the Assignee all of the Assignor's right, title and interest in and to the Intellectual Property, as defined hereinbelow.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor agrees as follows:

1. The Assignor does hereby assign, transfer and convey to the Assignee and its successors and assigns forever, as of the date first above written, all of its right, title and interest, whether statutory or common law, in, to or arising under, all of its United States and foreign patents; patent applications, including the inventions disclosed therein; trademarks; trademark applications; service marks; service mark applications; and domain names, as well as all licenses (to the extent assignable) relating to all of the foregoing, including but not limited to the patents, patent applications, trademarks, and trademark applications listed on Schedule A attached hereto and further including with respect to all of the foregoing the right of enforcement with respect thereto, including all rights to sue or recover for the past infringement thereof, and any and all choses in action related thereto (collectively, the "Intellectual Property").

2. If any Intellectual Property is not registered or recorded in the name of the Assignor, the Assignor agrees to comply with Assignee's request to supply the documents required for the assignment of such Intellectual Property as a result of that Intellectual Property not being in the name of the Assignor.

3. At the request of the Assignee and without further consideration, the Assignor shall promptly execute and deliver to the Assignee such agreements, certificates and other instruments of sale, conveyance, assignment and transfer and take such other action as may be reasonably requested by the Assignee more effectively to sell, convey, assign and transfer to and vest in the Assignee (or to put the Assignee in possession of) any of the Intellectual Property. The Assignor shall assist the Assignee in registering and/or recording the Intellectual Property with the appropriate governmental entities in any jurisdiction requested by the Assignee.

4. This Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware, without regard to its conflicts of law rules.

IN WITNESS WHEREOF, the Assignee has caused this Assignment to be duly executed and its corporate seal to be hereunto affixed as of the day and year first above written.
