

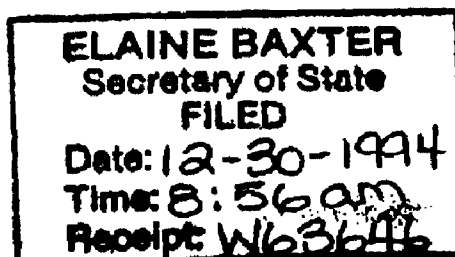
4. Number of partners in the partnership:

At the date of this application the number of partners in McGladrey & Pullen, LLP is five hundred forty-two. This includes eighteen individuals designated as "principals" in McGladrey & Pullen, LLP. This also includes one hundred fifty-two individuals who retired from active participation in the business of the partnership but are collecting retirement benefits from partnership income. Terminated partners are not included in the number of partners reported, even if still collecting termination payments from McGladrey & Pullen. Including principals and retired partners in this application is not, and shall not be deemed to be, for any purpose, an admission that principals or retired partners of McGladrey & Pullen are partners of McGladrey & Pullen.

The number of partners in McGladrey & Pullen varies with promotions, terminations, deaths and practice acquisitions. The partnership named eighteen new partners and principals to become effective February 1, 1995. These new partners are included in the partner count indicated above.
