Assignor agrees to execute and deliver at the request of Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts Assignee may require in order to vest all of Assignor's rights, title, and interest in and to the Trademarks and the associated goodwill throughout the United States and its territories to Assignee and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate this assignment, to the extent such evidence is in the possession or control of Assignor.

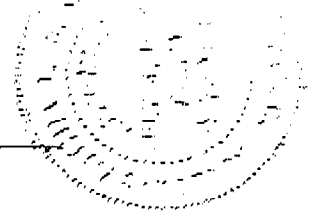
