

**ASSIGNMENT OF DESIGNS AND TRADEMARKS**

(i) All right, title and interest in the Trademarks, and any and all applications and issued registrations with respect to same, and the right to sue for past infringement of the Trademark. Assignor will execute any and all further documents necessary to transfer to Assignee title in and to the Trademarks and Designs.

(ii) All right, title and interest in the Designs, and all applications and issued registrations with respect to same, and the right to sue for past infringement of the Designs. Assignor will execute any and all further documents necessary to transfer to Assignee title in and to the Designs.
