ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS is made and entered into this 24th day of October, 1996, by and between Telebit Corporation, a California corporation ("Assignor") and Telebit (Newco) Inc., a Delaware corporation ("Assignee").

WHEREAS, pursuant to an Asset Purchase Agreement dated as of July 21, 1996 (the "Asset Purchase Agreement") between Assignor and Assignee, Assignee is purchasing from Assignor and Assignor is selling to Assignee certain Proprietary Rights including the foreign and U.S. trademarks, trademark registrations and applications for trademark registration listed in Schedule 1 (the "Trademarks");

WHEREAS, pursuant to the Asset Purchase Agreement, Assignor desires to assign and transfer to Assignee all of its right, title and interest in and to the Trademarks and Assignee desires to acquire the same;

WHEREAS, pursuant to the Asset Purchase Agreement, Assignor has agreed to execute and deliver such other documents and to take such other actions as may be necessary or desirable to consummate or implement the transactions contemplated by the Asset Purchase Agreement and to vest in Assignee good and marketable title to the assets transferred pursuant to the Asset Purchase Agreement, said assets including the Trademarks;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, sell, transfer and set over to Assignee, its successors, legal representatives and assigns, all of Assignor's right, title and interest in and to the Trademarks, together with the goodwill of the business in connection with which the Trademarks have been used or are intended to be used, and all claims, if any, which may have arisen thereunder prior to the date of this Assignment of Trademarks.
