ARTICLES OF INCORPORATION  
OF  
NAPA VALLEY TRADING CO.

I.

The name of this corporation is NAPA VALLEY TRADING CO.

II.

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

III.

The liability of the Directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

IV.

The corporation is authorized to provide indemnification of agents (as defined in Section 317 of the Corporations Code) for breach of duty to the corporation and its stockholders through bylaw provisions or through agreements with the agents, or both, in excess of the indemnification otherwise provided by Section 317 of the Corporations Code, subject to the limits on such excess indemnification set forth in Section 204 of the Corporations Code.

V.

If proceedings for dissolution of the corporation are instituted to which Corporations Code Section 2000 may apply, the provisions of any Buy-Out Agreement then in effect among the corporation's shareholders shall govern and supersede any provision of Section 2000 inconsistent therewith, to the extent required to enforce such agreement.
