

The undersigned being the duly authorized representative of Texwood Furniture Corporation, a Texas corporation, hereby executes these Articles of Conversion pursuant to Article 5.18 of the Texas Business Corporation Act ("TBCA") and certifies as follows:

- (a) The name of the converting entity is "Texwood Furniture Corporation" (the "Converting Entity"). The Converting Entity is a corporation incorporated under the laws of the State of Texas.
- (b) A Plan of Conversion for the Converting Entity has been duly approved in accordance with Article 5.17 of the TBCA and has not been abandoned.
- (c) An executed Plan of Conversion is on file at the principal place of business of the Converting Entity at 1353 West 2nd Street, Taylor, Texas 76574-0431 and will be on file from and after the conversion at the principal place of business of Texwood Furniture, Ltd., a Texas limited partnership (the "Converted Entity"), at 1353 West 2nd Street, Taylor, Texas 76574-0431.
- (d) A copy of the Plan of Conversion will be furnished by the Converting Entity (prior to the conversion) or the Converted Entity (after the conversion) on written request and without cost to any shareholder of the Converting Entity or to any partner of the Converted Entity.
- (e) Approval of the Plan of Conversion was duly authorized by all action required by the TBCA, the laws of the State of Texas and the Converting Entity's constituent documents. The Converting Entity has 1,000,000 shares of authorized common stock, \$1.00 par value (and no other authorized stock) with 74,518 shares outstanding, of which 74,518 shares voted for the Plan of Conversion and zero shares voted against the Plan of Conversion.
- (f) Under the Plan of Conversion, the Converted Entity will be liable for payment of all applicable fees and franchise taxes of the Converting Entity as required by law.
- (g) As provided in the Plan of Conversion, the conversion shall be effective at 12:01 a.m. on May 1, 2000.

PLAN OF CONVERSION

Pursuant to Article 5.17 of the Texas Business Corporation Act ("TBCA"), Texwood Furniture Corporation adopts the following Plan of Conversion to convert to a Texas limited partnership:

- 1. The names, state of formation, and organizational form of the converting entity and the converted entity are:
 - (a) Texwood Furniture Corporation, a Texas corporation ("Converting Entity"); and
 - (b) Texwood Furniture, Ltd., a Texas limited partnership ("Converted Entity").
- 2. The Converting Entity is continuing its existence in the organizational form of the Converted Entity.
- 3. The Converted Entity is to be a limited partnership under the laws of the State of Texas pursuant to this Plan of Conversion and will elect be treated as an association for federal income tax purposes only.
- 4. The manner and basis of converting the outstanding shares of common stock, \$1.00 par value, of the Converting Entity (the "Shares") into partnership interests of the Converted Entity are set forth herein. At the Effective Time (as defined in Paragraph 7 below) each shareholder of the Converting Entity will automatically own an interest in and be a partner of the Converted Entity in the same ratio as his or her outstanding Shares in the Converting Entity by virtue of the conversion as follows:
 - (a) the 72,226 Shares owned by Carolyn Gallagher will be converted into a 96.92% partnership interest as a limited partner in the Converted Entity;
 - (b) the 1,547 Shares owned by Kevin Golliher will be converted into a 2.08% partnership interest as a limited partner in the Converted Entity; and
 - (b) the 745 Shares owned by Texwood Furniture I, LLC will be converted into a 1% partnership interest as the general partner in the Converted Entity.

By its signature below, Texwood Furniture I, LLC hereby agrees to assume the powers and obligations of general partner under the Limited Partnership Agreement of the Converted Entity, arising from and after the Effective Time of the conversion. From and after the

Effective Time, the former holders of Shares shall be entitled only to their rights as partners under the Limited Partnership Agreement of the Converted Entity.

- 5. Attached as Exhibit A hereto is the initial Limited Partnership Agreement of the Converted Entity.
- 6. The Converted Entity will be liable for payment of all applicable fees and franchise taxes of the Converting Entity which are required by law.
- 7. The conversion shall be effective at 12:01 a.m. on May 1, 2000 (the "Effective Time"). Effective as of the Effective Time, the Converting Entity shall continue to exist without interruption, but in the organizational form of the Converted Entity, rather than its prior organizational form, with such other effects as set forth in Article 5.20 of the TBCA.
- 8. Upon approval of this Plan of Conversion by the shareholders of the Converting Entity in accordance with the TBCA, the President of the Converting Entity is hereby authorized to file Articles of Conversion with the Secretary of State.
- 9. The parties intend that the conversion pursuant to the Plan of Conversion will qualify as a tax-free reorganization under Section 368(a)(1)(A) or (F) of the Internal Revenue Code and such plan and documents implementing such plan shall be interpreted consistent with such intent.
- 10. This Plan of Conversion may be terminated at any time prior to the Effective Date, whether before or after approval by the shareholders of the Converting Entity, by vote of the board of directors of the Converting Entity.
