NOW, THEREFORE, for good and valuable consideration (the full and complete receipt of which is hereby presently acknowledged), Assignor hereby assigns to Assignees all right, title and interest in and to said OVER THE HEDGE trademark as exemplified by and including, but not limited to, the applications and registrations recited above, together with the goodwill of the mark symbolized by said applications and registrations, along with any and all rights to bring suit for past infringement by third parties of the mark(s) assigned and the recovery of related damages or settlements.
