BILL OF SALE

THIS BILL OF SALE made as of the 5th day of August, 2002 from Effanbee Doll Company, LLC, debtor and debtor-in-possession ("Seller") and Tonner Doll Company, Inc. ("Purchaser").

WITNESSETH

WHEREAS, Purchaser has made an offer to acquire from Seller substantially all of the Seller's assets (the "property"), more specifically identified as follows:

1. All molds owned by the Debtor, whether or not in the Debtor's possession.
2. Domain Name and web site address;
3. The name Effanbee Doll Company and all other product names, trademarks and any intellectual property.
4. Archival records of the Debtor including, but not limited to, account lists, customer lists, catalogues of product, supplier information.
5. All licensing rights.
6. Goodwill and associated information and contacts.

WHEREAS, by Order dated July 31, 2002 the United States Bankruptcy Court for the District of New Jersey approved the sale of the property by Seller to Purchaser (the "Order"), which Order is incorporated herein by reference.

NOW, THEREFORE, for and in consideration of the payment by Purchaser of the sum of _____ receipt of which is hereby acknowledged by Seller, Seller does hereby grant, bargain, sell, convey, assign, transfer, set over and deliver onto Purchaser the following property:

1. All molds owned by the Debtor, whether or not in the debtor's possession, as set forth more specifically on Schedule A annexed hereto. As forth on Schedule A hereto, certain molds may be subject to claims by certain licensors. This Bill of Sale transfers whatever right, title and interest the debtor holds in those molds. Moreover, certain molds are in a warehouse maintained by the debtor and the remaining molds are located as specified. This sale is "as is, where is".

2. The debtor's right, title and interest in all trademarks owned by or in which the debtor has an interest, including, but not limited to, those set forth on Schedule B annexed hereto.

3. The debtor's right, title and interest in any licenses which are currently in full force and effect. This sale is pursuant to 11 U.S.C. §363 only. The Seller has not assumed and assigned any licensing rights.

4. The name Effanbee Dolls and all other product names.

5. The domain name and web site address identified on Schedule C annexed hereto.

6. The telephone number of the debtor also identified on Schedule C annexed hereto.

7. All archival records of the debtor, including, but not limited to, account lists, customer lists, catalogues of products, supplier information.

9. All intellectual property in which the debtor has an interest.
