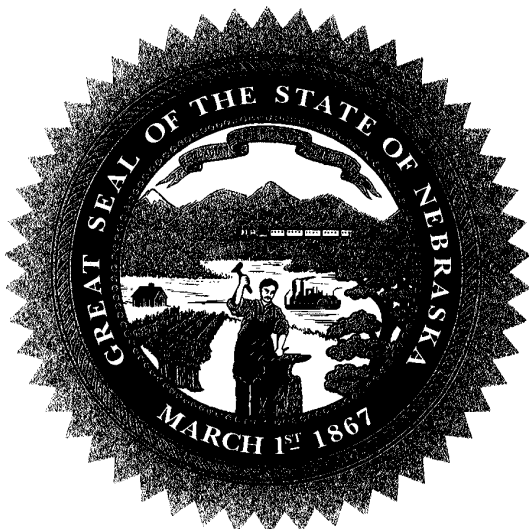

**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
INTERSYSTEMS, INC.**

Pursuant to Section 21-20,118 of the Nebraska Business Corporation Act, the undersigned corporation (hereinafter referred to as the "Corporation") adopts the following amendment to its Articles of Incorporation:

1. The name of the corporation is Intersystems, Inc.. The Articles of Incorporation are hereby amended to change the name of the corporation to I.S. Nebraska, Inc.

2. The following amendment was adopted in the manner prescribed by the "Nebraska Business Corporation Act":

Article First of the Articles of Incorporation is deleted in its entirety and the following is substituted therefore:

FIRST: The name of the corporation is I.S. Nebraska, Inc."

3. This amendment was adopted by the sole shareholder of the corporation on November 30, 1999.

4. Consent in writing to this amendment was given by all directors of the corporation and by the sole holder of all the shares entitled to vote thereon.

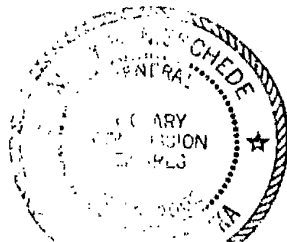
