

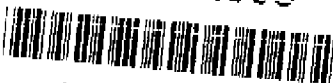

CERTIFICATE OF TERMINATION

THIS CERTIFICATE OF TERMINATION is made and delivered this 13th day of August, 2002, by PNC BANK, NATIONAL ASSOCIATION ("PNC").

WHEREAS, PNC and SUNLITE CASUAL FURNITURE, INC. ("Sunlite") entered into that certain Collateral Assignment and Security Agreement (Patents and Trademarks) dated as of April 10, 2000, in connection with that certain Revolving Credit, Term Loan and Security Agreement dated as of April 10, 2000 (collectively, the "Loan Agreements").

WHEREAS, pursuant to the terms of the Loan Agreements, as part of the consideration for the loan granted to Sunlite by PNC, PNC was granted a security interest in the trademarks owned by Sunlite set forth on Exhibit A attached hereto (the "Marks")

WHEREAS, as a result of Sunlite's default under the Loan Agreements, PNC exercised its rights to the collateral, including without limitation, the Marks pursuant to the terms of the Loan Agreements;

WHEREAS, as a result of such default, all right, title and interest of Sunlite in and to the Marks transferred to PNC in accordance with the terms of the Assignment;

WHEREAS, PNC intends to enter into an agreement to sell all right, title and interest to the Marks;

NOW, THEREFORE, PNC hereby terminates any and all security interest held by PNC in the Marks.
