TRADEMARK ASSIGNMENT AGREEMENT

THIS ASSIGNMENT is made as of the 30th day of June, 2000 by AG Communication Systems Corporation, a Delaware corporation, located and doing business at 2500 West Utopia Road, Phoenix, Arizona 85027 (hereinafter referred to as "Assignor") to JusticeTrax Inc., an Arizona corporation, located and doing business at 2501 West Behrend Drive, Suite 27, Phoenix, Arizona 85027 (hereinafter referred to as "Assignee").

WHEREAS, Assignor and Assignee have entered into an Agreement for the Purchase and Sale of Assets, dated as of February 28, 2000 (as amended the "Agreement") by the terms of which Assignee has agreed to purchase the assets and liabilities of Assignor's Laboratory Information Systems (LIMS) business, all as more fully set forth in the Agreement; and


WHEREAS, the Assignor is desirous of transferring and assigning to the Assignee, and the Assignee is desirous of acquiring from the Assignor, all of the Assignor's right, title and interest in and to the trademarks owned and used by Assignor in connection with its LIMS business, and all of the good will associated therewith, as well as the trademark registration set forth on Schedule A hereto and other rights the Assignor may have with respect to such assigned mark.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor does hereby transfer, convey and assign unto the Assignee all rights, title and interest in and to the assigned marks, and the registration identified on Schedule A hereto, together with the good will of the business appertaining thereto and which is symbolized by the assigned marks and the world wide right to sue for past infringements of the assigned marks.

The Assignor represents and warrants that it has no trademark registration for the mark JUSTICETRAX other than as set forth in Schedule A, and that it has not filed an application to register or reserve the assigned marks in any country, except for PathAssist in the United States. If and when the mark PathAssist is registered by the United States Patent and Trademark Office, Assignor agrees to assign such registered mark to Assignee. Further, the Assignor agrees not to make application to register or reserve the marks or any confusingly similar mark in any country after the date of this Assignment.

The Assignor shall execute any and all documents reasonably requested by Assignee to transfer ownership of the assigned mark listed on Schedule A hereto including, but not limited to, Assignments, Transfers and related Powers of Attorney.
