(U.S.)**

TERMINATION OF ASSIGNMENT OF TRADEMARKS AND SERVICE MARKS AGREEMENT dated February 8th, 2001 between CIBERNET Corporation, a District of Columbia corporation having its principal place of business at 1250 Connecticut Avenue, NW, Suite 800, Washington, D.C. 20036 (the "Assignor") and Deutsche Bank AG, New York Branch and/or Cayman Islands Branch (the "Bank").

WHEREAS, the Assignor and the Bank are parties to a Trademark Collateral Security and Pledge Agreement dated January 28, 1999 (as amended and in effect from time to time, the "Trademark Agreement"), between the Assignor and the Bank;

WHEREAS, pursuant to the Trademark Agreement, CIBERNET, agreed, *inter alia*, to grant the Bank a security interest and first priority lien on the trademarks and service marks (the "Marks") and identified on the Annex hereto and in accordance therewith executed and delivered to the Bank an Assignment of Trademarks and Service Marks (U.S.) dated January 28, 1999 (the "Assignment");

WHEREAS, pursuant to the Trademark Agreement, the Assignor authorized the Bank to complete as assignee and record with the United States Patent and Trademark Office the Assignment upon the occurrence of an Event of Default as such term is defined in a Term Loan Agreement between the parties dated January 28, 1999;

WHEREAS, the outstanding Obligations (as defined in the Loan Agreement) owed by Assignor to the Bank have been repaid in full and no Event of Default has occurred; and

WHEREAS, the parties are desirous of terminating the Assignment;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Bank does hereby terminate the Assignment and any and all rights, title and interest the Bank may have in and to the Marks, the registrations of and registration applications for the Marks, and the goodwill of the business symbolized by and associated with the Marks and the registrations thereof;

IN WITNESS WHEREOF, the Bank, by its duly authorized officer, has executed this Termination of Assignment, on this 8th day of February, 2001.
