Pursuant to RCW 23B.11.070 and 23B.11.050, the following Articles of Merger are executed for the purpose of merging Imation Publishing Software Corp, a Delaware corporation (the "Merging Corporation"), with and into ScenicSoft, Inc., a Washington corporation (the "Surviving Corporation").

1. The Agreement and Plan of Merger adopted by the Board of Directors of each of the Surviving Corporation and the Merging Corporation is as set forth on the attached Exhibit A.
2. The names of the corporations planning to merge are Imation Publishing Software Corp., a Delaware corporation, and ScenicSoft, Inc., a Washington corporation. The name of the Surviving Corporation is ScenicSoft, Inc.
3. Pursuant to RCW 23B.11.050, the merger was duly approved by the sole shareholder of Merging Corporation pursuant to RCW 23B.11.030.
4. Pursuant to RCW 23B.11.010(1), the merger was duly approved by the Board of Directors of the Surviving Corporation. Pursuant to 23B.11.030(7), approval of the shareholders of the Surviving Corporation was not required.
