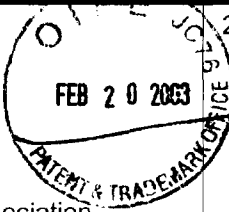

EXHIBIT A

ASSIGNMENT

This is an Agreement between MICASA TRADING CORPORATION d/b/a Impex Systems Group, Inc., a corporation of Florida, having a principal place of business at 2801 NW Third Avenue, Miami, FL 33127 (Micasa) and Kabushiki Kaisha Tokosha Corporation, a corporation of Japan, having a principal place of business at 12-16, Honkomagome 6-chome, Bunkyo-ku, Tokyo, Japan (Registrant).

WHEREAS, Registrant is the owner of United States Trademark Registration numbers 1,983,860 and 2,538,725, Serial Number 74/672,582, for the mark EXPRESS for scissors;

WHEREAS, Registrant is the owner of the trademark EXPRESS for scissors;

WHEREAS, Micasa is desirous of purchasing from Registrant said Registrations, trademark and the goodwill associated therewith;

WITNESSETH:

In consideration of the mutual promises set forth herein, Micasa and Registrant hereby agree as follows:

1. Registrant hereby assigns to Micasa said Registrations, said trademark and the goodwill associated therewith;
2. Micasa hereby agrees to pay Registrant \$10 and other good and valuable consideration for the assignment of said Registrations, trademark and goodwill. The attorney for Micasa,

Lowe Hauptman Gilman & Berner, LLP, will forward its check to the attorney for Registrant, Dykema Gossett, PLLC, upon proof that Registrant has submitted to the United States Patent and Trademark Office this Agreement assigning ownership of the Registrations, trademark and goodwill from Registrant to Micasa. The payment will be forwarded by the Micasa attorney to the Registrant's attorney within two working days of the Micasa attorney receiving proof of the filing.


3. The general trademark law of the United States is applicable to this Agreement, with regard to trademark provisions, and the law of Florida is applicable to the contract provisions of the Agreement.
