

3. The foregoing amendment to the Articles of Organization was adopted by the vote required by section 183.0404(2) of the Wisconsin Statutes.

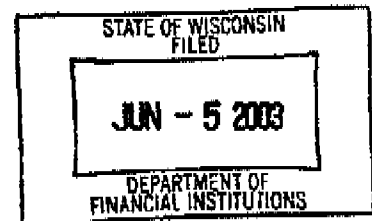
