SYMTX, INC., a Delaware corporation, under and in accordance with Section 252 of the Delaware General Corporation Law (the "DGCL"), hereby certifies that:

1. The name and state of incorporation of each of the constituent corporations in the merger are:
 - (a) Symtx, Inc., a Delaware corporation ("Symtx"); and
 - (b) Symmetrix, Inc., a Texas corporation ("Symmetrix").
2. An agreement and plan of merger has been approved, adopted, certified, executed and acknowledged by Symtx and by Symmetrix in accordance with the provisions of subsection (c) of Section 252 of the DGCL.
3. Symtx will be the surviving corporation following the merger, using the name "Symtx, Inc."
4. The certificate of incorporation of Symtx shall be the certificate of incorporation of the surviving corporation until thereafter duly amended in accordance with its terms and the DGCL.
5. The executed agreement and plan of merger is on file at the office of the principal place of business of Symtx, at 4401 Friedrich Lane, Building 2, Suite 200, Austin, Texas 78744.
6. A copy of the agreement and plan of merger will be furnished by Symtx, on request and without cost, to any holder of stock of Symmetrix or Symtx.
7. The authorized capital stock of Symmetrix is 42,500,000 shares of common stock, par value \$0.01 per share.
