NUNC PRO TUNC ASSIGNMENT

WHEREAS, Big City Radio, Inc., a Delaware corporation located and doing business at 1838 Century Park East, Los Angeles, California (the "Assignor") is the owner of the mark VIVA ALTERNATIVA, U.S. Trademark Application Serial No. 76/115,903 for registration of the mark VIVA ALTERNATIVA, and the goodwill symbolized the mark (collectively, the "Trademark"); and

WHEREAS, on April 16, 2003, Assignor sold, assigned and transferred all of its right, title, and interest in and to the Trademark, among other assets related to the business, to Entravision Communications Corporation, a California corporation located and doing business at 2425 Olympic Boulevard, Suite 6000 West, Santa Monica, CA 90404 (the "Assignee") pursuant to an Asset Purchase Agreement dated as of December 23, 2002; and

WHEREAS, the parties are desirous of ratifying and confirming said sale, assignment and transfer of all right, title and interest in and to said Trademark and the goodwill symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has assigned and hereby sells, assigns, transfers and sets over to Assignee, nunc pro tunc as of April 16, 2003, the entire right, title, interest in and to the Trademark, including U.S. Trademark Application Serial No. 76/115,903 and the goodwill of the business connected with the Trademark, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives.

Assignor further assigns to Assignee all right to sue for and receive all damages accruing from past infringements of the Trademark assigned.

This Assignment shall be binding upon the parties, their successors and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith.
