
AND the Assignor has agreed with the Assignee that the cession of the trademark application from the Assignor to the Assignee will carry with it the Assignor's goodwill in its business.

3. The Assignment of the said trademark registration takes effect from the 1st day of September 2001 and the Assignee accepts cession and transfer of the said trademark applications.




