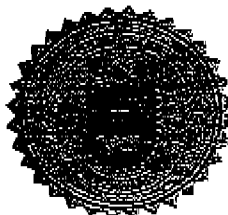

 and assumes all its obligations;


FURTHER RESOLVED, that the merger shall be effective upon
