CONFIRMATORY ASSIGNMENT OF TRADEMARK

WHEREAS, ABB Flakt AB, a Swedish corporation, having its principal place of business at SE-113 96, Stockholm, Sweden (hereinafter "ASSIGNOR"), was the owner of the entire right, title and interest, including goodwill, in and to the trademark DEPAC for which a U.S. registration was granted on October 12, 1982, Reg. No. 1,212,181 (hereinafter MARK); and

WHEREAS, United Conveyor International, Inc., an Illinois corporation, having its principal place of business at 2100 Norman Drive West, Waukegan, Illinois 60085-6753 (hereinafter "ASSIGNEE") acquired ASSIGNOR's entire right, title and interest in and to the MARK, and the goodwill symbolized by the MARK;

WHEREAS, ASSIGNOR and ASSIGNEE wish to memorialize said acquisition in an instrument suitable for recording;

NOW THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, ASSIGNOR does hereby sell, assign and transfer and confirm sale, assignment and transfer, unto ASSIGNEE, ASSIGNOR'S entire right, title and interest in and to said MARK, and the entire goodwill of that portion of the business symbolized by the MARK, together with the right to prosecute and recover for any past infringements thereof.
