TRADEMARK SECURITY AGREEMENT

SEAMAN FURNITURE COMPANY, INC.

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of June 19, 2003, by **HELLER FINANCIAL, INC.**, a national banking association, as agent (hereinafter in such capacity, the "Agent"), and in connection with the Loan and Security Agreement, dated as of December 22, 1997 (as heretofore amended and amended and restated, and in effect, the "Loan Agreement"), by and among **LEVITZ FURNITURE, LLC**, a Delaware limited liability company ("Levitz"), and **SEAMAN FURNITURE COMPANY, INC.**, a Delaware corporation ("Seaman"), and (Levitz and Seaman are sometimes collectively referred to as "Borrowers" and individually as a "Borrower"), the Agent and the lending institutions party thereto (the "Lenders").

WHEREAS, in connection with the Loan Agreement, the Borrower and the Agent entered into a Trademark Security Agreement, (the "Trademark Agreement") dated as of December 22, 1997, which Trademark Agreement was recorded December 30, 1997 with the United States Patent and Trademark Office at Reel 1667, Frame 0318 for the purpose of securing payment and performance of the Obligations (as defined in the Loan Agreement);


WHEREAS, pursuant to the Trademark Agreement, the Borrower granted to the Agent, for the benefit of the Agent and the Lenders, a security interest in, and granted, assigned and conveyed to the Agent, for the benefit of the Agent and the Lenders, by way of collateral security, the Borrower's entire right, title and interest in and to, the Trademark Collateral (as defined in the Trademark Agreement); and

WHEREAS, the Agent has agreed to terminate and release the Trademark Agreement and assign and transfer to the Borrower it's right, title and interest in the Trademark Collateral as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates and releases the Trademark Agreement and assigns and transfers to the Borrower, without representation, warranty or recourse, all of the Agent's right, title and interest in and to the Trademark Collateral, including without limitation the trademarks listed on Exhibit A attached hereto, effective as of the date set forth above.
