3. This assignment conveys to Assignee all of the goodwill of the business of Assignor symbolized by the trademarks, their use and the registrations thereof.

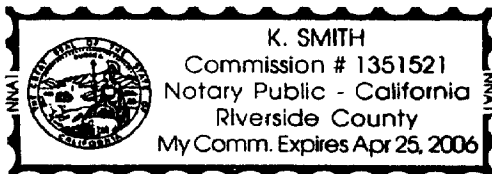
