RELEASE OF SECURITY INTEREST

WHEREAS, SCT CORPORATION, a Delaware corporation, having its principal place of business at 1600 John F. 

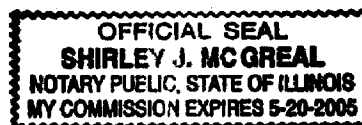
