ASSIGNMENT OF PATENTS AND TRADEMARKS

THIS ASSIGNMENT OF PATENTS AND TRADEMARKS (this "Assignment") is made as of the 18th day of February, 2003, by NORDEA BANK NORGE ASA, a Norwegian banking corporation formerly known as Christiania Bank og Kreditkasse ASA ("Nordea Norge"), and NORDEA BANK FINLAND PLC, a Finnish banking corporation formerly known as Merita Bank Plc ("Nordea Finland," and together with Nordea Norge, the "Previous Lenders"), in favor of ATLANTIC SALMON OF MAINE LIMITED LIABILITY COMPANY, a Maine limited liability company ("Atlantic Salmon"), with respect to the following facts:

A. Pursuant to that certain Collateral Assignment of Patents and Trademarks dated November 28, 2001 executed by Atlantic Salmon in favor of Previous Lenders, as amended by that certain First Amendment to Collateral Assignment of Patents and Trademarks dated January 8, 2002 between Atlantic Salmon and Previous Lenders (together the "Prior Assignment"), Atlantic Salmon assigned to Previous Lenders, among other things, all of Atlantic Salmon's rights in and to the "Patents" and "Trademarks" (as those terms are defined in the Prior Assignment), including, without limitation, the trademarks listed on the attached Schedule A and all of the goodwill of the business associated therewith.

B. Each of Previous Borrowers intends to provide to Nordea Norge a Continuing Guaranty (the "Guaranty") of the obligations of Fjord Seafood ASA, a Norwegian corporation ("New Borrower"), under: (i) that certain Multicurrency Loan and Guarantee Facility dated as of February 18, 2003 (as amended, supplemented or modified from time to time, the "New Loan Agreement") between Nordea Norge, as Lender, and for itself and any other Finance Parties (as defined in the New Loan Agreement), as Arranger, Issuing Bank, Agent, and Security Trustee (the "Agent"), the Finance Parties, Cultivadora de Salmones Linao Limitada, a Chilean corporation, as a borrower, and New Borrower, relating to a multi-currency credit facility in the aggregate amount of up to NOK 2,630,000,000.00 ; and (ii) that certain ISDA Frame and Security Agreement dated as of February 18, 2003 (the "ISDA Agreement") between Nordea Bank Norge ASA, New Borrower, Fjord Seafood Norway ASA, and Fjord Seafood Sales AS, relating to an ISDA Facility in the amount of NOK 250,000,000.00.

C. Previous Lenders intend to assign the Patents and Trademarks back to Atlantic Salmon so that Atlantic Salmon can, among other things, grant to Agent a security interest in the Patents and Trademarks under the New Loan Agreement and the ISDA Agreement.

NOW, THEREFORE, for valuable consideration, the sufficiency of which is hereby acknowledged, the parties covenant as follows:

1. Assignment. Previous Lenders hereby assign, transfer, and grant to Atlantic Salmon all of the rights in the Patents and Trademarks assigned by Atlantic Salmon to Previous Lenders under the Prior Assignment, including, without limitation, all of the right, title, and interest of Atlantic Salmon, previous to the Prior Assignment, in and to and arising from (a) trademarks, service marks, trade names, and trade styles, whether arising under common law, federal registration, or any foreign jurisdiction, and (b) patents, whether granted in the United States or any foreign jurisdiction; in either case, whether presently existing or hereafter acquired, including, without limitation, the trademarks listed on the attached Schedule A, all patent and trademark applications, registrations, and licenses, all of the goodwill of the business associated with the foregoing, and all products and proceeds of the foregoing, including claims for infringement, dilution, or injury to the goodwill associated with any trademark; provided, however, that such Patents and Trademarks are subject to that certain Security Agreement to be executed by Atlantic Salmon for the purpose of granting to Agent a security interest in, among other things, all of the foregoing, as security for Atlantic Salmon's obligations under the Guaranty (the "Security Agreement").

2. Security Agreement to be Filed. The parties hereby acknowledge that at the same time this Assignment is filed with the United States Patent and Trademark Office ("USPTO"), Nordea Norge will file a copy of the Security Agreement with the USPTO, with instructions that such copy be filed immediately after this Assignment.


3. Successors and Assigns. This Assignment and Memorandum shall be binding upon and inure to the benefit of the parties, their heirs, successors, and assigns.


