

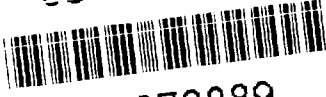


THIS AGREEMENT is effective as of *April 2*, 2001.


